

**OFFICIAL CALL**  
Mass Meeting  
of the Augusta County Republican Committee

I, Curt Lilly, Chairman of the Augusta County Republican Committee, hereby issue the Call for a Mass Meeting to be held in the Smith West Room at the Government Center, 18 Government Center Lane, Verona, at 7:00 p.m. on May 18, 2017 for the purpose of nominating a Republican candidate for the office of County Supervisor for the Pastures magisterial district, to be voted for in the general election on November 7, 2017.

If only one candidate pre-files for the District Board of Supervisor, the pre-filed candidate shall be declared the nominee and the Call for the Mass Meeting canceled.

### Qualifications for Participation

All legal and qualified voters of the Pastures District of Augusta County and under the laws of the Commonwealth of Virginia, regardless of race, religion, color, national origin or sex, who are in accord with the principles of the Republican Party and who will express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this Mass Meeting.

Military members that because of the obligations of their official military orders, are unable to attend the mass meeting, may in lieu of selecting delegates to represent them from their respective magisterial district, be represented by the Military Delegation. They shall send an e-mail declaration to the e-mail address below stating that they wish to be represented by the Military Delegation and include attached a signed statement of intent and affirmation of their official military orders precluding their attendance and their email address for correspondence. ### Filing requirements

All individuals interested in seeking the nomination for this office must submit a candidate filing form which will be available on the ACRC website ([AugustaVAGOP.com](http://AugustaVAGOP.com)) beginning April 3 to the Chairman of the Augusta County Republican Committee by 5:00pm., April 28, 2017, at the address below. The fee is \$250. Postmarks will not govern.
