

**2018 LYNCHBURG REPUBLICAN CITY COMMITTEE  
OFFICIAL CALL FOR A MASS MEETING**

As Chairman of the Lynchburg Republican City Committee ("Committee") of the Republican Party, pursuant to the Republican Party of Virginia Plan of Organization, and as recommended and directed by the Committee, I, Brian Keith Triplett, do hereby issue this call for a Mass Meeting to be held at the Liberty Mountain Conference Center, located at 3700 Candler's Mountain Rd, Lynchburg, VA 24502, registration starting at 6:30 p.m. and meeting beginning at 7:00 p.m., Eastern Time on Monday, March 26, 2018, or alternate location, date, and time, for the following purposes:

- 1) Elect the Lynchburg Republican City Committee Chair for the 2018-2020 term;
- 2) Elect members of the Lynchburg Republican City Committee for the 2018-2020 term;
- 3) Elect up to 1,445 Delegates and Alternate Delegates to the Sixth District Republican Convention to be held on May 19, 2018, at the James Madison University Convention Center, 895 University Boulevard, Harrisonburg, VA 22807 starting at 10 a.m. for the following purposes:
  - a. Elect a Chair for the Sixth Congressional District Committee of the Republican Party of Virginia for the 2018- 2020 term;
  - b. Elect a candidate for the U.S. Sixth Congressional District;
  - c. Elect a Central Regional Vice Chair for the Sixth Congressional District of the Republican Party of Virginia for the 2018-2020 term;
- 4) Select Republican Candidates for City Council At-Large seats for May 2018 election.
- 5) And for the transaction of such other business as may properly come before the mass meeting.

**QUALIFICATIONS FOR PARTICIPATION**

All legal and qualified voters in the City of Lynchburg under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception shall be approved for a voter who renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter who utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter. Within 30 days of receipt, the Official Committee shall provide a copy of this signed renunciation statement to the Republican Party of Virginia, to be maintained for a period of five years.

**FILING REQUIREMENTS FOR COMMITTEE MEMBERSHIP**

Candidates for election as a member of the Lynchburg Republican City Committee, and unable to attend the Mass Meeting, may prefile a written statement of their intent on a form provided by the Committee to the Lynchburg Republican City Committee, C/O Wendy Jacobs, Committee Secretary, 344 Bell Street, Lynchburg, VA 24501 or by physical delivery to 344 Bell Street, Lynchburg, VA 24501, which must be received not later than 6:00 p.m., on Monday, March 19, 2018. Postmarks do not govern. Candidates for Lynchburg Republican City Committee Chair shall include a \$250.00 check, nonrefundable fee, to the Lynchburg Republican City Committee when submitting their written statement. ### **FILING REQUIREMENTS FOR THE REPUBLICAN NOMINATION FOR AT-LARGE CITY COUNCIL**

Filing Requirements for At-Large City Council Candidates must prefile a written statement of their intent, on a form provided by the Committee to Lynchburg Republican City Committee, C/O Wendy Jacobs, Committee Secretary and mailed to 344 Bell Street, Lynchburg, VA 24501 or by physical delivery to 344 Bell Street, Lynchburg, VA 24501, which must be received not later than 6:00 p.m., on Monday, March 19, 2018. Postmarks do not govern. Candidates for At-Large City Council seats shall include a \$250.00 check, nonrefundable fee, to the Lynchburg Republican City Committee when submitting their written statement.
