

OFFICIAL CALL

Mass Meeting of the Highland County Republican Committee of the Republican Party of Virginia

As Chairman of the Highland County Republican Committee of the Republican Party, and pursuant to the Plan of Organization, and as recommended and directed by the Committee, I, Larry Bandy, do hereby issue this call for a Mass Meeting to be held at the Highland County Public Library, 31 Water Street, Monterey, Virginia on March 29, 2018 starting at 4:30PM, or alternate date and/or time, for the following purposes:

1. Elect a Unit Chairman
2. Elect members of the Unit Committee
3. Elect up to 17 Delegates and an equal number of Alternates to the 6th District Republican Committee Convention to be held on May 19, 2018 at James Madison University Convocation Center, 895 University Boulevard, Harrisonburg, VA 22807 beginning at 10:00AM for the purposes of:
 - A) Electing a Chairman for the Sixth Congressional District of the Republican Party of Virginia
 - B) Electing three (3) Regional Vice Chairmen of the Sixth Congressional District of the Republican Party of Virginia;
 - C) Nominating a Republican Candidate for the office of the U.S. House of Representatives
 - D) The transaction of such other business that may properly come before the Sixth Congressional District Republican Convention.
4. And for the transaction of such other business as may properly come before the Mass Meeting.

Please note: Highland County's maximum number of delegates for the 6th District Convention is 5 times its respective Delegate Vote or 85. Meaning up to 85 people would cast the County's 17 votes

Qualifications for Participation

All legal and qualified voters in Highland County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles

of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as unit chair at said Mass Meeting shall file the attached candidate statement form by mail or in person no later than 5:00PM on March 16, 2018, to Charlotte Stephenson, at 131 West Main St., Monterey, VA 24465. Postmarks do not govern.

A pre-file form for those seeking membership to the Highland County Republican Committee or who wish to be elected as delegates or alternates for the 6th District Convention is attached. Individuals may pre-file by submitting the attached form by mail or in person no later than 5:00PM on March 16, 2018 to Charlotte Stephenson, at 131 West Main St., Monterey, VA 24465. Postmarks do not govern.

No nominations may be made from the floor of the Mass Meeting

Please note: If not more than 1 person pre-files for chair AND not more than 15 people pre-file for committee membership AND not more than 85 people pre-file for the 6th District Convention, the qualified pre-filed people are considered elected and the mass meeting may be canceled.

A voluntary contribution of \$20 for the District Convention is requested of each delegate to defray costs. Failure to pay will not result in disqualification.
