

OFFICIAL CALL
Mass Meeting of the Shenandoah County Republican Committee
of the Republican Party of Virginia

As Chairman of the Shenandoah County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Timothy C. Carter, do hereby issue this call for a Mass Meeting to be held at the Sharon Lilly 4-H FFA Show Arena on the Shenandoah County Fairgrounds, at 300 Fairground Road in Woodstock, Virginia, starting at 6:30 p.m. local time on Friday, March 25th, 2022 for the following purposes:

- a) Electing a Unit Chairman;
- b) Electing members of the Unit Committee as follows:

And 26 at-large members of the committee;

- C) for the transaction of such other business as may properly come before the mass meeting.

Advance registration or pre-filing is not required to participate in the meeting. Registration will begin at 5:30 P.M. and will close at 6:30 PM, or at such time as registration of all those in line to register at 6:30 PM is complete.

Qualifications for Participation

All legal and qualified voters of Shenandoah County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing

as may be required, their pledge to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Election by Majority; Ranked Choice Voting

The Convention shall elect one candidate for Unit Chairman by majority vote determined, should the office be sought by more than two candidates, otherwise qualified and properly filed, by ranked choice voting.

Filing Requirements

Candidates for election as precinct member, at-large member or Chairman at said mass meeting shall file the form prepared by the committee and available via the methods below, by mail or in person, to Blake Phillips, 110 Larkspur Drive, Woodstock, VA 22664 or via email to insure@shentel.net. Forms for any office must be received not later than 5 p.m. on Friday, March 11th, 2022. In order to stand as a candidate for chairman, individuals must also remit a nonrefundable filing fee of \$300 no later than the above filing deadline. Postmarks do not govern.

To be listed as a candidate on the ballot for any office, the candidate must have remitted their filing fee and form by the required deadline. No nominations will be accepted from the floor. In order to stand for election as precinct member, said individual must presently be registered to vote at a location within the boundaries of that precinct as denoted in official voter records. Individuals who are found not to reside in the precinct for which they are standing for election will not be included on the ballot. Individuals who wish to be elected as at-large members may also register to stand for election as a precinct member and vice-versa; however, in the event that the individual is elected as a precinct member, they will be dropped from the final at-large ballot. In the event that the number of individuals filing for a given office does not exceed the total number of seats or offices available, all individuals shall be declared elected and no election shall be held. In the event that all offices are filled in this way, the Mass Meeting will be canceled and notice posted on www.shenandoahrepublican.com.
